USDA-NRCS Extends Application Periods for Conservation Programs

State Conservationist Carrie Mosley has extended the application period for two conservation programs to November 15th. All applications received for Agricultural Management Assistance (AMA) and the Environmental Quality Incentives Program (EQIP) by November 15 will be ranked and funds allocated after the new deadline.

These voluntary conservation programs are offered by USDA's Natural Resources Conservation Service in New Jersey to support conservation on agricultural and forested land. NRCS professionals work with producers to develop a conservation plan for their operation, design conservation practices and provide guidance to help implement the plan.

The Agricultural Management Assistance is a voluntary conservation program that targets beginning and limited resource farmers, small farms, and producers who have had limited participation in other USDA financial assistance programs. AMA provides financial and technical assistance to agricultural producers to address issues such as water management, water quality and erosion control by incorporating conservation into their farming operations.

The Environmental Quality Incentive Program is a voluntary conservation program for persons who are engaged in livestock, forestry or agricultural production, including organic production. EQIP offers financial and technical assistance to implement conservation practices on eligible agricultural land, and provides payments for implementing conservation practices that have a positive environmental impact, while protecting long term agricultural production and sustainability.

Food Safety Update

November 15th is the closing date for comments on the Food Safety Modernization Act (FSMA). We have been talking about this for a year, but now is the end of the comment period. There isn't time to read both documents (Produce Safety Rule and the Preventive Controls Rule) since they add up to several hundred pages. However, as I mentioned in the last issue of Cultivating Cumberland there is a series of fact sheets which the Food and Drug Administration put together to help explain the rules. Read these then check the proposed rules for the ones that impact you directly. Do not assume since you have a third party audit that FSMA will not impact your operation. Some wholesale growers think since they have an audit they are covered. Some retail (roadside and farm marketers) think it does apply to them. Both are wrong!

There are three parts of the proposed Produce Safety rule that should be a concern for New Jersey. Agricultural water (Subpart E) is defined as water that has potential or intent to come in direct contact with produce including sprays. If you are using drip on tomatoes it would not be agricultural water and would not need to be tested. However, if the same water is overhead irrigated it is agricultural water. If you use overhead to frost protect blueberries that are in flower it is not agricultural water. However, if the same water is used to protect strawberries that have fruit then it is agricultural water. The testing provision is the biggest concern. With municipal water you just need a copy of their analysis and wells need to be tested at the beginning of the season and every three months when in production. Those are really no problem. Surface water is the issue where they propose testing pond and stream water at least every 7 days! Testing for genetic E. coli will cost between \$50-95 per sample in New Jersey. If you irrigate from Mid-March to Mid-October (30 weeks) it will cost between \$1,500 to \$2,850 per water source. From the time the sample is collected until you get the results is at least 4 days if you can get it by email and by US mail at least 7 days. Which means you would need to pull another sample the same day you get the results. Don't you think you should comment about this? If you treat your water you do not need to test, but verify that the system is controlling the E. coli.

The second part which may be an issue for some growers is the Biological soil Amendments of Animal Origin (Subpart F). Anyone who is using raw manure (chicken, horse, cow, etc.) must wait 9 months from application to harvest assuming the manure will contact the harvestable crop. Based on this manure could only be applied in the fall. When using compost, if the source cannot provide information on their system for control of pathogens, the compost cannot be applied later than 45 days to harvest. If this is an issue, comment!

There are exemptions to the proposed rules based on income, but FDA is not clear on how income will be calculated. If a farm's average monetary value of <u>food sold</u> (including animal feed, grains, animals, etc.) in previous 3 years is less than \$500,000 and 51% of those sales are retail (direct to consumer, restaurant, retail food establishment, etc.) and within 275 miles where grown the operation would be exempt from some provisions. You would still need to have the farm name and address on the master container or a sign at a farmers market with the name and address of the operation.

Under the preventive controls rule some farms will need to register with FDA as a facility and may need to comply with other provisions of the rule. When a farm holds, handles or purchases products from another farm and are not exempt because of income they will fall under the preventive controls rule. FDA is asking for comments on the definition for a small business as one employing fewer than 500 persons and a very small business three options – less than \$250.000, less than \$500,000 or less than \$1 million in total annual food sales.

Preventive Controls for Animal Food Rule (PCAR.3) Who is covered by this rule?

This proposed rule would apply to animal facilities required to register under the FD&C Act that manufacture, process, pack, and hold ingredients and finished products that are intended to be fed to animals, including livestock, pets, and other animals. This includes renderers, pet food manufacturers, as well as biofuel manufacturers that supply distillers grain for animal food, and manufacturers of animal feed minerals and mineral mixes. This proposed rule would not apply to farms. However, if the farm operates an animal food manufacturing, packing, or holding business (in addition to its traditional farm activities), that food manufacturing, packing, or holding business, with certain exceptions, would likely need to comply with this proposed rule. The proposed rule would establish a series of exemptions (including modified requirements in some cases) from the requirements for hazard analysis and preventive controls for small, on farm facilities with low risk activity/animal food combinations. This is the last in a series that summarized findings from The Center for Produce Safety (CPS) fourth annual research symposium.. The full technical reports are available from the CPS website at cps.ucdavis.edu. The "10 key lessons" learned were summarized by Drs. Bob Whitaker and Jim Gorny representing the technical committee of CPS.

Pathogens can be transferred by wind. Growers have been encouraged to perform hazard assessments of production blocks prior to planting as part of their GAP programs. One of the key elements of the hazard analysis has been to evaluate the potential for contamination from concentrated animal feedlots should one be situated near the production block. Dr. Elaine Berry (USDA ARS) developed a study to examine the potential for wind-borne transference of *E. coli* O157:H7 from a herd of cattle known to be infected, to plots of leafy greens planted at varying distances from the cattle feedlot. The data demonstrate that *E. coli* O157:H7 can be transferred via bioaerosols and dust particles to crops at least out to 600 feet (the farthest distance tested). As distance increases away from the cattle feedlot, the frequency and level of contamination diminishes. However, bioaerosol and dust particle transference is not a simple matter of distance. The density of the cattle, wind intensity, moisture and activities within the feedlot; i.e. movement of cattle in or out, cleaning, etc., all impact formation of bioaerosols and dust particles containing pathogens. These factors must be considered in any hazard assessment and the development of management practices.

Animal intrusion: the road ahead? For the last several years, the produce industry has struggled to understand wildlife transmission of pathogens to crops and the role of riparian areas may play. Dr. Martin Wiedmann (Cornell University) is studying 24 produce field areas in New York State by examining landscape features, land use in adjacent areas, animal movement patterns and prevalence of genetic strains of E. coli in soil, animal and water samples to create models that might be used to forecast contamination events. While this work is still in the early stages, Dr. Wiedmann has shown that the prevalence of E. coli in environmental samples differs between landscapes and different cover types. It also appears that forests that border production fields might be acting as a source of E. coli that can be transmitted to the fields since a forest habitat harbors increased genetic diversity and can support higher levels of bacteria than the field environment. It's too soon to tell what this will all mean and how we can use this information to better understand the complex interactions between our production environments and food safety risk factors. However, this study marks an important departure in industry thinking relative to animal intrusion. Previous CPS-funded research has shown that there are no "risky" animal species, only animals that exist in environments where pathogens may be present and that they can be vectors for transferring those pathogens to crops. Dr. Wiedmann's work is one of the first real examples of how data might be used to build predictive models of how pathogens move through production environments. With this understanding, it may be possible to design crop production practices that find balance in environmental and food safety management.
