2014 Water Quality Initiative in South Jersey Watersheds

USDA, Natural Resources Conservation Service (NRCS) is offering technical and financial assistance to farmers in the Upper Cohansey River, Upper Salem River and Upper Alloway Creek Watersheds in Salem and Cumberland Counties through the 2014 National Water Quality Initiative (NWQI). "This is the third year NRCS has been able to offer this opportunity and support the effort to improve water quality in this area of New Jersey," State Conservationist Carrie Mosley said. These three watersheds have documented phosphorus, bacteria, and sediment impairments, which may be caused by soil erosion, exposed soil, and lack of riparian buffers and filter strips. Reducing agricultural runoff by implementing conservation practices on agricultural lands can help reduce phosphorus, bacteria, and sediment inputs.

NRCS designed the national Initiative for watersheds with known water quality issues and a high percent of agricultural land. Local watershed groups and state and federal agencies assisted NRCS in determining the NWQI focus area in New Jersey. The Upper Cohansey watershed has 68% of its land area in agriculture, the Upper Salem is 65% agriculture, and the Upper Alloway Creek has 41% of its land area in agriculture. "By focusing our conservation efforts with agricultural operators in these priority watersheds, we believe we help them have a positive impact on the water quality in that region," Mosley said.

Applications received by March 21, 2014, will be considered for funding this year. Farmers from the designated watersheds who are eligible for NRCS's Environmental Quality Incentives Program can apply for assistance to install conservation practices such as cover crops, filter strips and terraces. Application for the program can be made at the Natural Resources Conservation Service in Woodstown (51 Cheney Road, Suite 2, Woodstown, NJ 08098, ph: 856-769-1126 ext. 3) or in Vineland (Building 5, Suite A, 1318 South Main Road, Vineland NJ 08360 ph: 856-205-1225).

2014 Plastic Pesticide Container Collection Schedule

(It's a FREE program and 1 CORE credit will be issued to participants with NJDEP Pesticide licenses)

This program is offered to agricultural, professional and commercial pesticide applicators who hold a NJDEP pesticide license. State, county and municipal government agencies may also participate. A representative from the NJ Department of Agriculture will be on-site to inspect the containers and issue one core credit to pesticide license holders who follow all of the required processing steps. To receive credit, participants must bring their pesticide license to the collection site and must follow all of the processing steps. Core credits will not be issued to participants who fail to follow all of the pesticide container processing steps.

Plastic Pesticide Container Processing Steps & Size Limits:

- 1. All pesticide containers must be either triple rinsed or pressure rinsed, drained and dry inside;
- 2. All pesticide containers must be free of residue (other than stains);
- 3. The booklet <u>must</u> be removed (it is not necessary to remove the paper labels glued to the container);
- 4. Foil seal must be removed;
- 5. Only non-refillable pesticide containers will be accepted you <u>must</u> drill a ¼-inch hole in the <u>bottom</u> of the container or with a utility knife make a 6-inch slit in the <u>bottom</u> of the container so the container will not hold liquids;
- 6. Only pesticide containers embossed with HDPE or the recycling #2 will be accepted;
- 7. Pesticide containers up to 55-gallons in capacity will be accepted. 5-gallon pales must be cut in half; 30-gallon containers into at least 4 pieces; and 55-gallon containers into at least 8 pieces. This can be accomplished using a sawszall, chainsaw, circular saw, or reciprocating saw. It is not necessary to cut up containers less than 5-gallons; and
- 8. Pesticide containers must have originally held an EPA registered pesticide.

Items That Will Not Be Accepted and Will be Returned to the Recipient:

- 1. Pesticide containers with dried formulation on the container, pour spout or the spout threads;
- 2. Pesticide containers with any liquid residue;
- 3. Pesticide containers where the insides are caked with dried residue;
- 4. Mini-bulk, saddle tanks and nurse tanks, which can be made of fiberglass;
- 5. Pesticide containers with lids; or
- 6. Containers that held any type of petroleum oil product or antifreeze.

Non-Waxy Cardboard Collection

Atlantic and Salem County collection sites: Helena Chemical will also be accepting, at no charge, non-waxy cardboard from their customers since their products are sold to the end user in cardboard boxes. Every Friday during the months of April through October from 1p.m. to 3 p.m and during the scheduled pesticide container collection times, cardboard will be accepted. Clean non-waxy cardboard must be broken down and flattened. The flattened cardboard must be tied for the Atlantic County collection site. Tying in not required at the Salem County collection site. Clean Non-waxy cardboard will also be accepted year-round at the Cumberland County Solid Waste Complex's Convenience Center.

Other Rigid Plastic Recycling

If you generate other clean non-petroleum containing HDPE plastic (nursery pots, crates, buckets, pales, etc.), the Cumberland County collection site may accept the material. Contact Karen Kritz, Recycling Manager, NJDA, 609-984-2506 to see if the plastic can be recycled. If you have large plastic containers (like a large quantity of HDPE drums) that you cannot cut up, contact Karen Kritz to see if accommodations can be made to accept them at the Cumberland County site ONLY.

Eligibility: □ Academic Scholarship:

The applicant must be enrolled at and in the academic rank of sophomore, junior or senior at any accredited 2-year or 4-year college or university in the United States when receiving the scholarship. The applicant must be a New Jersey resident majoring in an agricultural subject area (ie. Botany, Plant Science, Animal Science, Agronomy, Entomology, etc) or other related fields. The applicant must also intend to pursue a career in production agriculture or in a field related to agriculture. The applicant (or parent, if under 21) must be a current member of NJ Farm Bureau. In the event of two equally qualified applicants, deference will be given to the applicant residing in Somerset County.

□ Continuing Education Scholarship:

The applicant (or parent, if under 21) must be a current member of NJ Farm Bureau and will be attending an accredited or approved seminar, workshop, or conference related directly to production agriculture or a field related to agriculture. The committee will review both the applicant and the seminar for eligibility. This scholarship will be awarded by March 1 of the following year, but will be transferred only after the successful applicant has attended the approved conference. Applicants in this category must be at least 18 years of age. In the event of two equally qualified applicants, deference will be given to the applicant residing in Somerset County.

- 2) An official copy of transcripts from most recent college attended
- 3) Two letters of recommendation (1 academic / 1 non-academic) from non-family members
- 4) A 1-2 page essay (double spaced, typed) stating goals, plan of study and any other pertinent information regarding education and career (separate paper)
- 5) List all other scholarships applied for or received in the previous year
- 6) All of the information must be received by March 31st

Letters of recommendation are to be sent by person writing the recommendation directly to the Scholarship Chairman at the address listed on the application form. Do not send letters of recommendation with the application, transcripts, and essay.

member and president of the Somerset County Board of Agriculture, a member and first vice-president of the New Jersey Farm Bureau, and an active member in the Land Use Committee, New Jersey's Direct Marketing Association, Vegetable Growers' Association, and Grain and Forage Producers Association.

Tom's family: wife, Kris, and children Rachel, Kaitlin and David, supported his great contributions to the farming community, and carry on his legacy in Somerset County.

New Jersey Environmental Protection Pesticide Control Program Regulations

"...a spill is defined as any intentional or unintentional action or omission resulting in the releasing, discharging, leaking, pumping, pouring, emitting, emptying, or dumping of any pesticide to any location which is not a labeled and intended site..." (NJAC 7:30-1.2)

Reportable Spills (NJAC 7:30-9.17) -- only certain spills have to be reported to the NJDEP:

- 1. Outside a structure if more than
 - · 1 pound active ingredient
- 2. Inside a structure- if more than
 - · 1 pound active dry pesticides
 - · 1 gallon liquid (pesticide &/or diluent)
- 3. Termiticide indoor spill
 - >50 in 2 organochlorine termiticide contamination at 1 injection point
 - >1 yd2 aggregate contaminated by organochlorine termiticide on/at interior wall base
 - · when heating duct/system is contaminated

Who is responsible to report: licensed dealer, dealer business, commercial pesticide operator, applicator or applicator business, shall notify the Department of any reportable pesticide spill occurring under such person's direct supervision and/or direct observation.

When to report: call NJDEP immediately at 1-877-927-6337. Follow up within 10 days with a written report to: Pesticide Control Program, P.O. Box 411, Trenton, NJ 08625-0411.
