Cessation of Tailpipe Emission Testing

State of New Jersey Division of Motor Vehicle Commission Www.state.nj.us/mvc/Inspections/tailpipe.htm

Beginning May 1, 2016, the NJ Motor Vehicle Commission is changing the inspection requirements for certain vehicles including vehicles with farmer tags. Due to the cessation of tailpipe emission testing, the following passenger vehicles now will be exempted from inspection:

- Gasoline powered vehicles registered passenger, model year 1995 & older with a GVWR 8,500 pounds or less
- Gasoline powered vehicles registered passenger, model year 2007 & older with a GVWR 8,501 to 14,000 pounds
- Gasoline powered vehicles registered passenger, model year 2013 & older with a GVWR 14,001 pounds or more

A passenger vehicle is considered any vehicle registered with one of the following registration codes:

- 1 through 9
- 12 (not utilized to transport passengers as in the manner of a bus)
- 15, 31 and 73

You can find your registration code on your registration as illustrated below:



Additionally, owners of the exempted vehicles will be sent a notice six to eight weeks before their vehicle would have been due for inspection. Owners should remove the inspection sticker once it expires and keep the notice received in the vehicle.

What is the difference between an audit and an inspection for food safety?

Over the last 15 years we have talked about third party audits to verify your food safety plan. Now you are hearing about inspections. What is the difference? Audits are voluntary evaluations that growers are doing at the request of their buyers. Some may not think that audits are voluntary since some growers have been told if they did not have one a specific buyer would not purchase their produce. That is true, but you still had the choice to sell to someone else if you did not want to go through the audit process. The audit was verifying what you said you were doing for food safety.

The Food Safety Modernization Act (FSMA) has added the inspection component to food safety. The final FSMA rule went into effect January 2016. As FSMA is implemented over the next two to four years, growers will hear more about inspections and how it may impact their operations. The Food and Drug Administration (FDA) now has more authority for fresh produce which adds another layer of compliance for growers. Inspections will be done by a government entity with specific requirements and implies some type of enforcement in the future. FDA is not in any hurry to start an enforcement program. They have made it clear that education is the first priority, but in reality sometime in the future there will be enforcement. Who will do the inspections is still being decided between FDA and the different states. In New Jersey, the New Jersey Department of Agriculture will probably be the lead agency as it relates to farms and on farm packing-houses.

There is a group of extension personnel from Florida, Michigan, New Jersey and North Carolina working with the National Association State Departments of Agriculture on a grant from the FDA to develop an On Farm Readiness Review. This will be a self-assessment tool for growers, extension personnel and inspectors to help everyone when a farm is inspected. The plan is to have the final version available next year.

Growers will receive training over the next year to help comply with the Produce Rule in FSMA. The good news is growers who have been through a third party audit already meet or exceed most requirements for FSMA. Water testing is the one area where there are differences, but the training will help clarify those differences.

Will the inspection take the place of a third party audit or vice versa? The answer is no at least not in the near future. FSMA is considered the baseline for food safety. Most wholesale buyers probably will not accept FSMA as sufficient for food safety plus, most audit companies will continue to use their own audits. The US Department of Agriculture is assessing whether they can change their basic Good Agricultural Practices (GAP) audit to match the FSMA requirements. This will not happen for this year or next, but probably in the future.

Growers will need to be aware of changes in food safety both in practices and pathogens. Food safety is a dynamic process which will continue to change as we develop new methods of pathogen detection and determine which are the more important organisms or practices.

Pesticide Storage Inventory due May 1 to Fire Department

Licensed pesticide applicators and dealers in New Jersey who store pesticides are required by law to send a copy of their inventory along with a cover letter to their local fire company by May 1st each year.

Applicators and dealers must maintain a list of the pesticides stored or likely to be stored during the year. The inventory should be kept separate from the storage area. Applicators and dealers must keep the letter on file for three years and should have it available for NJDEP upon request. This does not apply to pesticides for personal use, or to storage of pesticides at loading or application areas for less than 7 days.

- 1. Pesticide Storage Inventory Form The purpose of the inventory is to provide local fire departments with a description of materials stored in case of fire or emergency. We suggest filling out one per storage address of your operation.
- 2. Cover Letter Template Licensed pesticide applicators and dealers who store pesticides are required by law to send a cover letter with a copy of the inventory to the local fire company. NJDEP regulations require that, "The cover letter will state that this list has been sent pursuant to N.J.A.C. 7:30-9.5(b).4." New Jersey regulations require a description or diagram depicting the specific location on the property where the pesticides are stored. The cover letter has a space to write the location or indicate a diagram is enclosed.

What's the difference between subscribing by RSS or Email?

RSS (Really Simple Syndication) is a technology that allows organizations to deliver news to a desktop computer or other Internet device. By subscribing to RSS feeds, users can easily stay up-to-date with areas of the Plant and Pest Advisory site that are of interest.

The Plant and Pest Advisory offers several RSS feeds for use in an RSS reader or RSS-enabled Web browser.

RSS feeds consist of a headline, brief summary, and a link that leads back to the web site for more information.

An RSS reader collects and displays RSS feeds, allowing you to scan headlines from a number of news sources in a central location. Some browsers have built-in RSS readers; some RSS readers are free stand-alone programs. Feedly lists a number of options for various operating systems and browsers.

The Plant and Pest Advisory offers you the very same information in either an RSS feed or by email. The difference is the RSS will go to your RSS reader while the email will go to your inbox. You may find one is more convenient or easier to use than the other. For example, RSS feeds won't get trapped in your email spam filter. On the other hand, you may prefer to have all information go to your email inbox.

NJDA's Al Murray set to retire

Alfred W. Murray, whose distinguished career with the New Jersey Department of Agriculture spans 33 years, will be retiring from the department this fall. Murray, who will be 55 years old this June 26, will officially announce July 1 his decision to retire from the department on Nov. 30.

I "I absolutely love this industry and I love what I do," Murray told *The Produce News*. "I've accomplished all I can here. It's just time for new challenges and new opportunities."

Murray, a resident of Audubon, NJ, and who served as mayor of that community from May 1989 to May 1997,
joined the New Jersey Department of Agriculture in October 1983 as a marketing specialist. He was named bureau chief of the department's Bureau of Market Expansion in 1995, and director of the Division of Markets in 2000. He added the title assistant secretary of agriculture in 2007, and currently serves under New Jersey Secretary of Agriculture Douglas H. Fisher.

Arthur R. Brown Jr. was the state's secretary of agriculture when Murray first came aboard, and Murray said that his proudest accomplishment in state government was working with Brown and others to develop the Jersey Fresh Promotional Program.

I "Starting from the ground floor and making the Jersey Fresh program a success — and a nationally recognized program — I take great pride in that," Murray declared.

Murray acknowledged that since he will be only 55 when he "retires" this November from the department, he definitely wants to stay engaged in some area of agriculture or produce. "My goal is to stay in the agricultural sector," he said. "Maybe merchandising or marketing. I love this industry, and I've made lifelong friendships."

But he has no firm plans beyond that. "I have no idea what's going to happen," he admitted with a mixture of both uncertainty and excitement. "But I can't wait!"
